The Perry Public Library Board of Trustees met in regular session on Thursday, September 14, 2023 at 9a.m. Note: This meeting was held in-person at the Perry Public Library.

Board members Margaret Ruggle, Rosa Gonzalez, Mark Miller, and Heather Karolus were present. Friends' of the Library President Kathy Miller, Friends' Vice President Becky Rueter, Library Director Mary Murphy, and Deputy Library Director Misty VonBehren were also present.

Library Board President Mark Miller called the meeting to order.

Agenda – Heather Karolus moved to approve the agenda with Rosa Gonzalez seconding the motion. MCU.

Minutes – Heather Karolus moved to approve the minutes from the August 11, 2023, meeting and Rosa Gonzalez seconded the motion. MCU.

Financial Statements – Gift Fund receipts and payments were presented with receipts totaling \$4,157.99 and checks #6494 - #6505, totaling \$2,672.05. The City of Perry Library Fund Status Report was reviewed. Heather Karolus moved to approve the financial reports with Maggie Ruggle seconding the motion. MCU.

Unfinished Business:

Children of Employees at Work Policy was reviewed, Maggie Ruggle moved to approve with Rosa Gonzalez seconding the motion. MCU. This policy will be added to Perry Public Library's Personnel Manual.

Children of Employees at Work

The purpose of this policy would be to provide guidance on and outline the circumstances and conditions under which minor dependent children of employees (or minor children within the care of custody of an employee) may be present within the Library and Museum workplace. At this time, if an emergency arises, you must contact the Library Director if you are bringing your child (under age 18 and not employed by the City of Perry) to work.

Employees are welcome to bring their children to visit their worksite, provided that the visits are infrequent, brief, and planned in a fashion that limits disruption to the workplace. While children are in the workplace, they must always be supervised by the host/parent. If the frequency, length, or nature of visits becomes problematic, the employee will be advised of the situation and will be expected to take corrective action.

Director Review – Director Mary Murphy will send the Library Board a self-review. The emebers of the Board will review and send their comments to Library Board President Mark Miller. Director Murphy and Library Board President will meet to discuss the comments.

New Business:

Library Roof – The Library roof was inspect on September 7, 2023. The report will be coming in the next week. Their comments were mainly about the clogged drainage lines coming off the roof. There were some surface scratches and color fading.

Board Education: We discussed throughout the meeting about privacy laws and how recent legislation could affect the library's state funding and resources.


The library director contacted ISG to evaluate some leaking occurring on the library roof. The library was constructed in 1992. The library roof is a standing seam metal roof. Seams are mechanically crimped. Generally, overall, the roof is in good condition. Original workmanship appeared to be good based on final appearance of some of the details.


We first viewed areas inside the building where leaks and concerns were occurring. One area was in the SE corner of the library and another area was the flue in the boiler room.

The roof is a 4/12 pitch and was able to be walked during the site visit. The following was observed:

The leak in the SE corner appears to be related to gutters that have too much debris in them and water is not draining fast enough. There was a conduit cut into the back of the gutter at the down spout for heat tapes and the seal on the conduit was broken. Water would back up in the gutter and enter into the building through the end of the conduit. The height of the conduit is just above the flow line of the gutter. So, with a blocked downspout it doesn't take a lot of water to enter into the conduit.

Other areas on the building also exhibited plugged downspouts and some vegetation growing in the gutter. This was discussed with the owners and suggested that the gutters be cleaned as soon as they can, so they are not dealing with cold weather or frozen debris to be removed. All gutters including the clearstory should be cleaned. The conduit should be resealed and checked periodically as it would be expected that the seal could fail every few years depending on the methods used.





While not specific to any roof leaks some of the seams on the gutter for the upper clearstory are developing leaks and should be sealed. Access to see the inside of the gutter wasn't possible but it should be checked for corrosion and repairs made accordingly. Some touch up paint would help improve the outer appearance.



The next area was around the chimney in the boiler room. The original flue was a large diameter flue and the heating equipment has since been replaced. The new heating equipment uses the original flue for the PVC vent pipes. The old flue was modified to serve as a "boot" for the PVC pipes. Review of the detail revealed that the base of the original flue is just caulked in place. The original flue would have been deemed a hot pipe and would require some special flashings to properly seal it. The flue is no longer considered a hot pipe and a new roof flashing should be installed. Care should be taken when installing that roof flashing so a pathway for water to drain from upslope of the flashing is maintained.

It would appear a #7 or #8 round EPDM roof jack or pipe flashing boot would be the size needed. The base of those will exceed the distance between the ribs so maybe a # 9 might be an option so it can be formed over one of the ribs.

There are retrofit flashing that are split (See photo below) and can wrap around the pipe. Given the height of the of the flue and varying diameters from the top down this may be a better solution to try to use.


Depending on availability there are some manufacturers that offer a green color that would blend into the roof color better than a standard black or gray. This may not be available in all products but something to consider if it is available.

The PVC pipes were cut through the rain cap of the original flue. The screen that the exhaust gases would have exited from, was covered with a piece of sheet metal. This metal is not completely tucked under the rain cap and may have moisture getting in from the top and causing leaking as well. The top of the original flue is exhibiting rust. The gases and moisture from the high efficiency heating equipment is corrosive and may be causing deterioration.

The vertical seams and joints of the old flue have been caulked as well. The seams of the roof panels are not completed at the old flue. The seaming machines would have been too large to get past the flue so it is removed and reset once its past the obstruction. It does not appear the seams were hand crimped at that location.

The old flue is starting to fail as far as being watertight. It is understandable why they installed the new PVC pipes in the old flue but it may be necessary to start all over and redo the entire detail. The challenge is the large hole for the original flue leaves a large hole in the roof.









The flues are close to the next higher roof height and probably need to be as high as they are to exhaust properly. If they can be installed lower, a shorter base could replace the old flue and a univeral cap could be installed similar to photo below. Combined with the roof jack size there could be a way to remove some of the problem areas.



Other plumbing vents on the roof shown some weak points and may be subject to failure soon. It would be advisable to replace all the pipe flashings at this time. Normally the roof jack rubber is clamped to the pipe to get a good seal. The one in the photo on the left below just has caulk. The other one appears to have a cover on it and the roof jack is hidden under it and may be more of a hidden issue. Depending on the conditions present a new colored cover could be fabricated to cover the pipe and flashing and make it less obvious or depending on the situation the pipe could be painted as well.






There are some sidewall details that need attention. One of the areas has a wide-open gap and could have water enter in there. I can only assume that the overhang has afforded it enough protection that it wasn't been an issue in the past. This should be addressed and made watertight. This one was on the north side of the building. All similar conditions need to be inspected closer.



Another location has some water damage at the EFIS. There is no kickout flashing present. That type of flashing wasn't really a term when this was built but has become a code required item as a result of some poor installations. It's going to be a variation of the detail shown below but the end result is the same. This should be added at all locations where the eave does not extend past an adjoining wall.



One of the ends has some cracked brick. My guess is the brick is setting on the roof deck and over time it has settled. This should be reconstructed to repair the crack and a kickout flashing also incorporated. There is also a smaller hole in the flashing that isn't quite visible in the photo that should be sealed as well.



At another location the end wall flashing is not sealed correctly to the end wall. Again, the overhang has probably saved some problems. This should be sealed. It will require incorporating a kickout flashing as well and maybe a counter flashing. A counterflashing would go over the current flashing and be similar to the detail below.







All caulking on the building is at the point it needs to be replaced. The clear story windows above had some holes in the caulking. We noticed failure around other windows and control joints.



We also did a quick review of the masonry. The windowsills which we would call a sky facing joint should all be addressed. This also includes the tops of the screen walls. Some have been caulked. Properly done the caulking does a good job but they are still a maintenance issue and should be reviewed every year since they are all visible from the ground.






The screen wall in the SE corner has some damage to it. And the screen wall in the NW corner has more damage to it than the SE corner. Both are receiving water damage and left uncorrected significant damage will happen. The wall is constructed with some 4" block as a back up wall. This is not ideal as 4" block does not have the ability to fill the cores. There are cracks occurring in the NW corner wall. Repairing those is probably only temporary (10years??) and pushes the eventual reconstruction of the entire wall down the road. The wall reconstruction should have some modifications to the original detail and utilize a larger block behind the brick. Ideally that is an 8" block. If that was done, everything would need to be redone as even the footings would not be wide enough. So, it's a major repair when that happens.





There are also areas where the brick itself is damaged or cracked. Most appears to be related to water freeze/ thaw damage. Faces of the brick have popped off and were laying on the ground next to the wall. Control joints weren't present and could be related to some cracking at the corners. It also might be possible that the wrong mortar was used in the brick (too hard or strong) and a softer mortar would potentially prevent some of the brick faces from popping off.




Inside the library the ceiling of the clear story was pointed out as having some damage. This one is a little more difficult to determine its exact cause. We weren't able to get up on the clear story roof but from what we observed from the ground the roof panels and ridge cap look in good condition so it probably isn't related to a roof damage or failure.

The original plan details show a vapor barrier on the ceiling and a vented space. All of what we would do today. We feel the ceiling damage is related to condensation. In the detail, the ridge is a beam and there is no insulation that prevents thermal transfer and it might be possible that that ridge gets very cold because its directly under the vented ridge.

Another possibility is the vents at the ridge or eaves are plugged and its not getting enough air movement. They can be difficult to clean sometimes but that would be something to check and see if they are obstructed and the "attic" space isn't properely venting anymore.

A third possibility is that at times the ridge vent could allow snow to filter in and that melts at some point.

Continue to monitor the area and document when changes are noticed. The time of the year can help rule in or rule out possibilities.



As far as the roof, overall we feel the roof is sound except for the pipe flashings and the end wall details mentioned above. Getting these addressed should reduce chances of water infiltration.

You'll probably experence paint failure on the roof before you start getting leaks the are related to the metal roof panels. There are some scratches where surface rust is starting but none were observed to be severe. The paint has faded and is starting to chalk in spots.

There were some loose soffit and fascias that should also be fastened back in the correct location. It was indicated that those conditions may be from the effects of the dericho a few years ago.

Overall the building is in good shape but it is at that age some repairs are required and if they are done in a timely manner it will reduce the possiblity of more severe damage occuring.
